If a cat/kitten you are fostering needs veterinary care, you MUST consult with one of the contacts listed to get approval and ONLY take your cat/kitten to one of Cat Haven Rescues approved veterinarians/facilities. Cat Haven Rescue will NOT reimburse you if you choose to take a cat/kitten to a veterinarian without approval OR if you take a cat/kitten to a veterinarian/facility not approved by Cat Haven Rescue.
2. Many of the cats/kittens in need of fostering have NOT yet been tested for FIV/FELV or any other contagious diseases/illnesses. Due to this, all fosters must be kept separate from both your cats and any other cats/kittens you foster through Cat Haven Rescue.
3. All cats and kittens in the foster program are property of Cat Haven Rescue. You may NOT sell, give away, or adopt out ANY cats/kittens you foster through Cat Haven Rescue. If you, a friend, or a family member are interested in adopting a cat/kitten you are fostering, you/they will need to fill out an adoption application and go through Cat Haven Rescues adoption screening process.
